

1. This NOC is as per the RTE Act, 2009 and not linked to the G.I.A. of O.E. Act of the State Government.
2. The School shall be opened for inspection by the Inspecting Officers of School and Mass Education Department.
3. No financial assistance and grant-in-aid (both recurring and non-recurring) shall be claimed by the institution from the Government at any point of time for meeting the salary cost and its component towards teaching and non-teaching staff appointed by the Managing Committee.
4. The Managing Committee of the School will not shift the present location of the School without prior approval of Director, Elementary Education, Odisha.
5. The Managing Committee shall be constituted in accordance with the Section-7 of Orissa Education Act, 1969.
6. The Managing Committee shall ensure the continuity of all eligibility criteria for grant of N.O.C. If any deterioration from present status of the School is detected at any point of time then the N.O.C. shall be withdrawn.

7. If at any point of time, it is found that information submitted by the Schools is not in conformity with the field position, appropriate Administrative as well as legal action against the school authority will be initiated besides withdrawal of NOC.


