- The School shall be opened for inspection by the Inspecting Officers of School and Mass Education Department.

- 7. If at any point of time, it is found that information submitted by the Schools is not in conformity with the field position, appropriate Administrative as well as legal action against the school authority will be initiated besides withdrawal of NOC.
