No. IV-SME/E(I)-92/2011 3722 /SME, Government, after careful consideration, have been pleased to re-designate the post of Inspector of Schools as "**District Education Officer**".


The Scale of Pay of the District Education Officer will be the same as that of the existing Inspector of Schools. The jurisdiction of the District Education Officer shall be the Revenue District and he/she will be the Chief Officer of School & Mass Education Department for the concerned district. The District Inspector of Schools (DIS) whose jurisdiction is limited to the Education Districts within a Revenue District, shall work under the supervision and guidance of the "**District Education Officer**".

The word 'Inspector of Schools' now prevailing in different Codes and Manuals shall henceforth be read as "**District Education Officer**".

This has been concurred in by Finance Department vide their UOR No. 15-SS-I dated 30.1.2012.
