NOTIFICATION

In pursuance of Clause (b) of Sub-section-2 of Section-13 of the Right of Children to Free and Compulsory Education (RCFCE) Act 2009, the State Govt. do hereby decide to prohibit screening procedure i.e. any test or interview / interaction of the child or interview / interaction of the parents for admitting a child to school. Only random procedure shall be used for admitting a child to school. This prohibition would apply to all schools as per sub section (n) of Section-2 of the Act.

Anyone who subjects a child to screening procedure shall be punishable with fine up to twenty five thousand rupees for the first contravention and fifty thousand rupees only for each subsequent contraventions.
