

A High level meeting was held on compliance of RTE norms for grant of recognition/NOC to Privately Managed Elementary Schools on 01.11.2014

After carefully examining the present status of the RTE norms, the following decisions were taken keeping in view the larger interest of the students who have been enrolled in these Schools.


1. All applications received upto the date of meeting i.e. 01.11.2014 will be taken into consideration for issue of N.O.C.
2. Conditional N.O.C. will be issued to the privately managed Elementary Schools with the conditions that they will fulfill all the requirements as per RTE Act by **31.10.2015**. However,
  - (a) They will give an undertaking/affidavit in this regard.
  - (b) At least 50% of the teachers should be trained and for remaining, they should show enrolling in the training course.
  - (c) They should upload last year report in the Website regarding the progress. NIC to provide Software solution for the same.
3. In order to ascertain the financial viability of the Schools applying for NOC, indicators will be worked out and OPEPA will revise the software accordingly in consultation with NIC. If the per child cost is less than 50% of the cost mentioned by our expert committee, then the school deserves no NOC.
4. Schools having "Play classes" and "Pre-Primary (LKG, Nursery etc.)" will not come under the ambit of issue of NOC. However, the safety and security of the child to be ensured by the school as per the prevailing guidelines/rules of the Government. OCPCR may take up such cases.
5. Applications received will be sent "on-line" to the concerned BEOs for field verification. Based on the filed report, NOC is to be considered.
6. The BEOs after getting the applications "on-line" will conduct field enquiry and while submitting report, specifically give comments on the non-negotiable items mentioned above.

7. The Block Education Officer will submit the verification report "on-line" with the counter signature of the concerned District Project Coordinator within 15 days of receipt of the applications from the Directorate of Elementary Education, Odisha.


